2. **[Case No. 2025-2-AZON Dugas Subdivision and the Clifton Chenier Center Administrative Rezoning](#)**

A request to rezone property from CH (Commercial-Heavy) to MN-1 (Mixed-Use Neighborhood), RM-1 (Residential Mixed) and PI-L (Public/Institutional Light) located generally north of West Willow Street, east of Patterson Street, and south of Martin Luther King Jr Drive.

3. **[Case No. 2025-3-AZON University Avenue District Overlay Administrative Extension](#)**
