# **2010 LRPD MASTER'S LEAGUE RULES**

**REGULAR NATIONAL FEDERATION RULES (HIGH SCHOOL) WILL BE USED WITH THESE FOLLOWING EXCEPTIONS:**

- 1) **MATCHES ARE BEST TWO OUT OF THREE RALLY SCORING TO 25 IN FIRST TWO GAMES AND TO 15 IN THIRD, MUST WIN BY TWO AND NO CAPS.**
- 2) **THREE MALE TOUCHES ARE ALLOWED IN PLAY.**
- 3) **“LET” SERVES ARE NOT ALLOWED. (SIDE OUT – POINT)**
- 4) **RESTRICTIONS ON “DINKS” AND “DUMPS” ARE THE SAME AS REGULAR INDOOR QUAD RULES. NO FINGER ACTION ABOVE THE NET AND “INTENTIONAL” SETTING OVER THE NET MUST BE DONE WHILE SQUARE TO THE NET.**
- 5) **THERE ARE NO FRONT OR BACK ROW PLAYERS. SERVICE ORDER MUST BE RETAINED.**
- 6) **KICKING REMAINS LEGAL AS IT IS IN FEDERATION RULES.**
- 7) **ALL MATCHES WERE BE OFFICIATED BY PLAYERS PARTICIPATING IN THAT MATCH UNLESS AN AGREED UPON PERSON IS AVAILABLE. ONCE SOMEONE OFFICIATES THEIR CALLS MUST BE ACCEPTED. NO PROTESTS IN THIS LEAGUE.**
- 8) **AFTER THE REGULAR SEASON IS DONE PARTICIPANTS WILL CHOOSE WHETHER TO PLAY ADDITIONAL REGULAR MATCHES, A TOURNAMENT OR SOME TYPE OF PLAYOFF FORMAT. THESE MATCHES WILL TAKE PLACE ON MARCH 17, 24 & 31 OR ALL DAY ON A SATURDAY IN MARCH (3-20 OR 3-27).**
- 9) **ALL PARTICIPANTS WILL BE ASSESSED \$25 FEE TO PLAY THE REGULAR SEASON AND \$5 FOR ANY POST-SEASON (INCLUDES A SHIRT). A MINIMUM FEE WILL BE ADDED IF OFFICIALS ARE DESIRED AT ANY TIME.**
- 10) **PARTICIPANTS THAT ARE NOT CURRENTLY PLAYING ON A CO-ED 6'S TEAMS WILL BE REQUIRED TO SIGN AN ADDITION/DELETION CARD TO ENSURE LIABILITY ISSUES.**
- 11) **TWO (2) PLAYERS ARE REQUIRED TO START THE MATCH. PARTICIPANTS MUST BE 40 YEARS OLD BEFORE APRIL 1, 2010.**
- 12) **EACH PLAYER ON THE WINNING TEAM IN EACH MATCH WILL GET A POINT IF THEY ARE THE REGULARLY SCHEDULED PLAYER. IF A PLAYER CANNOT MAKE THE MATCH THEY CAN CALL ANY OTHER PLAYER OF THE SAME GENDER TO FILL-IN AND THE OTHER TEAM MEMBERS EARN THE POINT. FILL-INS DO NOT QUALIFY FOR THE POINTS ONLY REGULARLY SCHEDULED PARTICIPANTS. IF A MAN FILLS-IN FOR A WOMAN THEN THAT TEAM CANNOT EARN A POINT; MATCH WILL STILL BE PLAYED.**
- 13) **POINTS WILL BE USED TO SEED FOR PLAYOFFS/TOURNAMENT AND KING/QUEEN AWARDS. EVERYONE WILL QUALIFY FOR ANY POST-SEASON.**
- 14) **BECAUSE THERE ARE AN ODD NUMBER OF TOTAL PARTICIPANTS THERE ARE SEVEN PLAYERS THAT WILL PLAY NINE MATCHES. THERE FIRST EIGHT MATCHES WILL COUNT FOR “KING” & “QUEEN” POINTS.**
