BYOB EXCEPTION PERMIT AFFIDAVIT

An applicant may be issued a BYOB Exception Permit for an event hall or similar place of business from the office of Alcohol and Noise Control for certain locations, which allows patrons to bring their personal alcoholic beverages into/onto the premises; and/or rents out the premises to a third party for events. Applicant shall meet and maintain **ALL** of the requirements and conditions as outlined below:

1. Applicant meets all requirements of Lafayette City Parish Consolidated Government Code of Ordinances Sec. 6-34(e) and La. R.S. 26:80 and La. R.S. 26:280.
2. Completes an Alcoholic Beverage Permit Application and pays all fees for a Class A permit as required by Lafayette City Parish Consolidated Government Code of Ordinances Sec. 6-35.
3. The location shall have a public habitable floor area of no less than five hundred (500) square feet dedicated to the exclusive use of the applicant's or licensee's business. This does not include any kitchen, bars, hallways, or restrooms.
4. The location must be equipped with a permanent wet bar equipped with a non-movable sink.
5. Applicant is prohibited from selling alcoholic beverages without first obtaining a Special Event Permit as required by Lafayette City Parish Consolidated Government Code of Ordinances Sec. 6-37.
6. It is a violation of the BYOB Exception Permit or any other permit issued in accordance with Lafayette City Parish Consolidated Government Code of Ordinances Chapter 6, for anyone under the age of 21 to be in possession of or consuming any alcoholic beverage while on the premises of the permitted location.
7. Applicant shall maintain compliance with all federal, state and local laws, all state and local building codes, fire codes, health codes and other applicable codes/statutes/ordinances.
8. Applicant shall not allow any person to enter with an **OPEN CONTAINER** of alcoholic and/or non-alcoholic beverages from any other business.
9. It is prohibited for the owner, manager and/or employee or anyone working for the owner or manager, of licensed business, to sell, serve or store any alcoholic beverages unless said business holds a Special Event Permit as required by Lafayette City Parish Consolidated Government Code of Ordinances Sec. 6-37.



10. Any event having 75 or more persons in attendance shall have law enforcement security. The number of persons in attendance shall not exceed the posted Capacity as set by the Lafayette Fire Department's Fire Prevention Division or the State Fire Marshal's Office.
11. Applicant will fully review and comply with all other provisions of Chapter 6 of the Lafayette City Parish Consolidated Government's Code of Ordinances and Title 26 of the Louisiana Revised Statutes and Title 55 of the Louisiana Administrative Code.
12. Applicant understands this BYOB permit shall not be utilized in lieu of a Special Event Permit.
13. Applicant understands the premises is subject to inspection at any time by local law enforcement and/or the office of Alcohol and Noise Control.

Failure to comply with any of the above requirements shall constitute a violation of the BYOB Exception Permit and the business is subject to the provisions of the Lafayette City Parish Consolidated Government Code of Ordinances Sec. 6-4 and Sec. 6-5.
