

PROCEDURE FOR OBTAINING A NOISE VARIANCE PERMIT

Dear Applicant:

Lafayette Consolidated Government's Alcohol and Noise Control Division is pleased to have this opportunity to serve you. In order for us to issue your Noise Variance Permit quickly and efficiently, please follow the instructions below.

Our office is located at the Clifton Chenier Center, 220 W. Willow Street, Building C, Ste. 102, Lafayette, Louisiana.

1. Your completed application, valid government issued pictured ID and application fee must be received by our office at least two business days prior to your event.
2. The application fee for a Noise Variance Permit ranges from \$25 - \$45, depending on the number of consecutive days you are requesting the Noise Variance. There is no application fee for a non-profit organization who can provide verification of their 501 (c)(3) status.
3. If you are not the property owner, where your event is scheduled to take place, you must provide **a letter of permission from the PROPERTY OWNER**. The written approval must give permission to obtain a Noise Variance at said location, including dates, times, type of event you are having, owner's name, owner's contact number and signature.
4. If your event is open to the public, law enforcement security may be required. If law enforcement security is required, it must be approved prior to your permit being issued.
5. Additional requirements may be necessary prior to the issuance of a Noise Variance Permit.
6. You may print and complete the application prior to visiting our office, or you may complete your application when you arrive.
7. If approved, your permit will be issued no sooner than the next business day.

The application fee is NON-REFUNDABLE and cannot be used for dates other than the dates noted on the application.
