The Lafayette Consolidated Government reserves the right to inspect permitted sites at any given time and upon written notification, the Applicant will have 10 calendar days to correct noted deficiencies.

Failure to correct noted deficiencies will result in the suspension of all construction related inspections until noted deficiencies are corrected and approved by the Public Works Department.

The undersigned applicant hereby represents that he has performed the necessary research to ascertain the existence and location of all servitudes, easements, setbacks, restrictive covenants, building restrictions, deed restrictions and other matters which may have an impact or effect upon the site which construction is to be made pursuant to this permit.

I acknowledge that I have been advised that I am obligated to build/maintain a minimum five (5') foot tall fence enclosing the pool with a self closing, self latching gate in accordance with the applicable provisions of ordinances governing the enclosure of pools for the City- Parish of Lafayette. (Ordinance No. O-155-2011) I understand that I may not qualify for a final inspection of the pool and that electrical service to the pool may be withheld until such time as I have complied with the applicable ordinance relative to swimming pool enclosures.

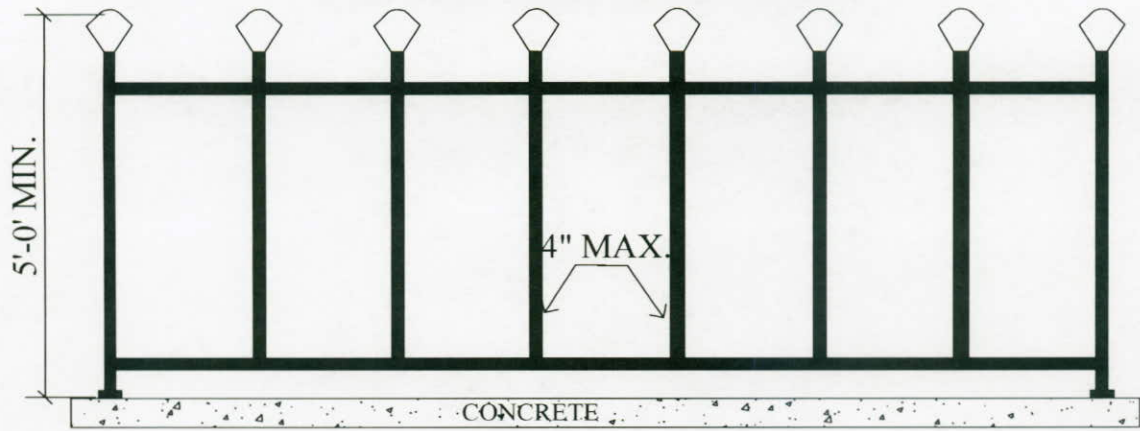
