

**MAYORAL PROCLAMATION:
EMERGENCY ORDERS TO ADDRESS COVID-19 EMERGENCY**

WHEREAS, in response to the public health emergency resulting from the novel (new) coronavirus named "SARS-CoV-2," with the disease it causes having been named "coronavirus disease 2019" or "COVID-19;"; Mayor-President, Joshua S. Guillory, issued a Declaration of State of Local Disaster and/or Emergency dated March 15, 2020 and recorded as Act Number 2020-9192 in the records of the Clerk of Court of Lafayette Parish, Louisiana (the "Emergency Declaration") which is still in full force and effect; and

WHEREAS, the Governor of Louisiana declared a state-wide public health emergency pursuant to Proclamation Number 25 JBE 2020, issued on March 11, 2020, as well as Proclamation Number 27 JBE 2020, 29 JBE 2020 and 30 JBE 2020, issued on March 14 - 17, 2020, Proclamation Number 32 JBE 2020, 33 JBE 2020, 37 JBE 2020 & 38 JBE 2020 issued March 19 - 31, 2020, Proclamation Number 41 JBE 2020, 43 JBE 2020 and 52 JBE 2020 issued April 2, 2020 - April 30, 2020, Proclamation Number 58 JBE 2020 and 59 JBE 2020 issued May 14, 2020, Proclamation Number 74 JBE 2020 and 75 JBE 2020 issued June 4, 2020; Proclamation Number 83 JBE 2020 and 84 JBE 2020 issued on June 25, 2020; and Proclamation Number 89 JBE 2020 issued July 11, 2020; and

WHEREAS, due to a spike in confirmed cases of COVID-19, immediate measures are necessary to contain the spread of COVID-19, including, but not limited to, taking measures to restrict person-to-person contact; and

WHEREAS, on June 26, 2020, Mayor-President Joshua S. Guillory issued orders continuing certain immediate measures, prohibiting gatherings of more than 200 persons in certain situations as one of those measures, and providing for related matters; and

WHEREAS, on June 27, 2020, Mayor-President Joshua S. Guillory issued an order clarifying the scope of the June 26, 2020 orders.

NOW, THEREFORE, Joshua S. Guillory, City-Parish Mayor-President for Lafayette City-Parish Consolidated Government, hereby declares the following, effective at midnight on July 25, 2020 and continuing until 11:59 PM on August 7, 2020:

1. The travel and movement of unaccompanied minors within Lafayette Parish is restricted in the following manner: During the hours of 8:00 PM to 6:00 AM, unaccompanied minors within Lafayette Parish are not allowed in any public place or place open to the public, including (but not limited to) the streets of Lafayette Parish, during the hours of 8:00 PM to 6:00 AM. Unaccompanied minors who are employed and are required to travel within Lafayette Parish during curfew hours may be exempted from this travel restriction on a case-by-case basis.

2. There shall be no congregating or loitering on sidewalks, streets or public areas in the area bounded by Evangeline Thruway, West Congress Street, Lafayette Street, University Avenue, and Johnston Street, specifically including, but not limited to, Parc Sans Souci, Parc de Lafayette, Parc Putnam, Parc International, Jefferson Street, and any other public gathering areas or greenspaces within this geographic area (commonly referred to as "the downtown area"). Excepted from this order are queues for entry into a lawfully operating business of 20 persons or less, provided that the persons in such queue observe proper social distancing measures. Violation of this portion of the emergency declaration shall subject the violator to a citation under Louisiana Revised Statute 29:727(G) which provides for a Five Hundred (\$500) Dollar fine and up to six (6) months in jail or both.
3. City-Parish Hall, the Public Works Building and Clifton Chenier Center shall be closed to the public; however, the drive-thru services shall remain operational for servicing the public.
